

## USP–NF Online: Proposal for Changes to Title and Format

**Type of Posting:** General Announcement

**Posting Date:** 14–Sep–2018

USP is announcing proposed changes to the title and format of the *USP–NF*. These changes align with the transition to a fully electronic publishing model for USP publications, including the *USP–NF*, and solidifying one source for official text.

This notice is one mechanism intended to communicate the proposed changes as well as to solicit feedback.

Beginning in 2020, the *USP–NF* will transition to publishing three online-only publication updates per year. USP plans to continue publishing accelerated revisions and errata on a monthly basis. There will be no change to publishing dates, official dates associated with scheduled publications, or the six-month implementation period.

Once per calendar year, a non-official volume of the *USP–NF*, which will include all associated revisions and additions, will be available in print and/or USB flash drive format. This volume is intended to serve as a historical reference document and is not considered official text. USP is interested in feedback on whether a print copy or print-format PDF on USB drive edition would be preferred by users.

USP is also changing the publication title to align with the electronic format. The new publication title format will be as follows:

*USP–NF* 2020 Issue 1

*USP–NF* 2020 Issue 2

*USP–NF* 2020 Issue 3

The term “supplement” will be eliminated, as the *USP–NF* Online will always include the complete, up-to-date set of standards.

General Notices will communicate that the revision/edition increases with each publication, three times per year (not just once per year as it does now).

- February 2019: Last print supplement (*Second Supplement* to *USP 42–NF 37*)
- November 2019: Last print book in current format (*USP 43–NF 38*)

- February 2020: Starting with *USP–NF* 2020 Issue 1, updates published online only (see table above for a full list of publication and official dates)
- February 2021: *USP–NF* 2020 Paper Edition, Non-Official
