In accordance with the Rules and Procedures of the 2015–2020 Council of Experts, the Chemical Medicines 5 Expert Committee has revised the Montelukast Sodium Chewable Tablets monograph. The purpose for the revision is to widen the *Acceptance criteria* for *cis*-isomer in Table 2, *Organic Impurities*, from NMT 0.2% to NMT 0.3% to be consistent with the FDA-approved specification. The limit of total impurities remains unchanged.

The Montelukast Sodium Chewable Tablets Revision Bulletin supersedes the currently official monograph.

Montelukast Sodium Chewable Tablets

DEFINITION

Montelukast Sodium Chewable Tablets contain Montelukast Sodium equivalent to NLT 92.5% and NMT 107.5% of the labeled amount of montelukast ($C_{35}H_{36}CINO_3S$).

[NOTE—Avoid exposure of samples containing montelukast to light.]

IDENTIFICATION

• A. <u>Spectroscopic Identification Tests (197)</u>, <u>Ultraviolet-Visible Spectroscopy</u>: 1970 Diluent: <u>Methanol</u> and <u>water</u> (3:1)

Standard solution (for 4-mg Chewable Tablets): 0.026 mg/mL of <u>USP Montelukast Dicyclohexylamine</u> <u>RS</u> in *Diluent*

- **Standard solution (for 5-mg Chewable Tablets):** 0.033 mg/mL of <u>USP Montelukast Dicyclohexylamine</u> <u>RS</u> in *Diluent*
- **Sample solution:** Nominally (*L*/200) mg/mL of montelukast, where *L* is the label claim of montelukast in mg/Chewable Tablet prepared as follows. Transfer 1 Chewable Tablet to a suitable volumetric flask, add 25% of the flask volume of <u>water</u>, and let stand for 5–10 min until the Chewable Tablet has disintegrated. Add 55% of the flask volume of <u>methanol</u>, shake well, and sonicate for 70 min with occasional shaking. Cool to room temperature, dilute with <u>methanol</u> to volume, and mix well. Centrifuge a portion of the resulting solution to obtain a clear solution.

Wavelength range: 210-400 nm

Acceptance criteria: The *Sample solution* exhibits maxima only at the same wavelengths as the *Standard solution*.

• **B.** The retention time of the major peak of the *Sample solution* corresponds to that of the *Standard solution*, as obtained in the *Assay*.

ASSAY

• PROCEDURE

Diluent: Methanol and water (3:1) **Solution A:** 0.2% (v/v) <u>Trifluoroacetic acid</u> in water **Solution B:** Methanol and acetonitrile (3:2) **Mobile phase:** See <u>Table 1</u>.

Standard solution: 0.33 mg/mL of USP Montelukast Dicyclohexylamine RS in Diluent

- **System suitability solution:** Transfer 10 mL of the *Standard solution* to a clear 10-mL volumetric flask, add 4 μ L of <u>hydrogen peroxide</u>, and mix well. Expose the flask for at least 4 h to ambient light or 10 min to a 4 klx cool white light. [Note—Montelukast is partially converted to the *cis*-isomer under these conditions.]
- **Sensitivity solution:** 0.33 µg/mL of <u>USP Montelukast Dicyclohexylamine RS</u> in *Diluent* from the *Standard solution*
- **Sample solution (for 4-mg Chewable Tablets):** Nominally 0.24 mg/mL of montelukast prepared as follows. Transfer 12 Chewable Tablets to a suitable volumetric flask, add 75% of the flask volume of *Diluent*, and shake vigorously for 60 min. Dilute with *Diluent* to volume. Pass a portion of the resulting solution through a suitable filter of 0.45-µm pore size, discarding the first mL of filtrate. Use the filtrate.
- **Sample solution (for 5-mg Chewable Tablets):** Nominally 0.25 mg/mL of montelukast prepared as follows. Transfer 10 Chewable Tablets to a suitable volumetric flask, add 75% of the flask volume of *Diluent*, and shake vigorously for 60 min. Dilute with *Diluent* to volume. Pass a portion of the resulting solution through a suitable filter of 0.45-µm pore size, discarding the first mL of filtrate. Use the filtrate.

Chromatographic system

(See <u>Chromatography (621), System Suitability</u>.)

Mode: LC

Detector: UV 255 nm

Columns

Guard: 3.0-mm × 4-mm; packing <u>L11</u>

Analytical: 4.6-mm × 10-cm; 3-µm packing L11

Column temperature: 50°

Flow rate: 1.5 mL/min

Injection volume: 20 µL

Run time: 2 times the retention time of montelukast

System suitability

Samples: Standard solution, System suitability solution, and Sensitivity solution

[NOTE—The relative retention times for the *cis*-isomer and montelukast are about 0.92 and 1.0, respectively.]

Suitability requirements

Resolution: NLT 1.5 between the *cis*-isomer and montelukast, *System suitability solution* **Relative standard deviation:** NMT 2% for five injections, *Standard solution* **Signal-to-noise ratio:** NLT 10, *Sensitivity solution*

Analysis

Samples: Standard solution and Sample solution

Calculate the percentage of the labeled amount of montelukast ($C_{35}H_{36}CINO_3S$) in the portion of Chewable Tablets taken:

 r_{II} = peak response from the Sample solution

 $r_{\rm S}$ = peak response from the Standard solution

- $C_{\rm S}$ = concentration of <u>USP Montelukast Dicyclohexylamine RS</u> in the *Standard solution* (mg/mL)
- C_{II} = nominal concentration of montelukast in the Sample solution (mg/mL)
- M_{r1} = molecular weight of montelukast, 586.18

 M_{r_2} = molecular weight of montelukast dicyclohexylamine, 767.50

Acceptance criteria: 92.5%–107.5%

PERFORMANCE TESTS

• **Dissolution** $\langle 711 \rangle$

Test 1

Medium: 0.5% (w/v) <u>Sodium dodecyl sulfate</u> in <u>water</u>; 900 mL. Do not deaerate.

Apparatus 2: 50 rpm

Time: 20 min

Solution A: 0.2% (v/v) Trifluoroacetic acid in water

Solution B: 0.2% (v/v) Trifluoroacetic acid in acetonitrile

Mobile phase: Solution A and Solution B (1:1)

Standard stock solution (for 4-mg Chewable Tablets): 0.30 mg/mL of <u>USP Montelukast</u> <u>Dicyclohexylamine RS</u> in <u>methanol</u> (equivalent to 0.23 mg/mL of montelukast)

Standard stock solution (for 5-mg Chewable Tablets): 0.35 mg/mL of USP Montelukast

Dicyclohexylamine RS in methanol (equivalent to 0.27 mg/mL of montelukast)

- **Standard solution:** (*L*/900) mg/mL of montelukast in *Medium* from the *Standard stock solution*, where *L* is the label claim in mg/Chewable Tablet of montelukast
- **Sample solution:** Pass a portion of the solution under test through a suitable filter or centrifuge to obtain a clear solution.

Chromatographic system

(See <u>Chromatography (621), System Suitability</u>.)

Mode: LC

Detector: UV 389 nm

Column: 3.0-mm × 10-cm; 5- μ m packing <u>L11</u>

Column temperature: 50°

Flow rate: 0.9 mL/min

Injection volume: 50 µL

Run time: 1.5 times the retention time of montelukast

System suitability

Sample: Standard solution

Suitability requirements Tailing factor: NMT 1.5

Relative standard deviation: NMT 2%

Analysis

Samples: Standard solution and Sample solution

Calculate the percentage of the labeled amount of montelukast ($C_{35}H_{36}CINO_3S$) dissolved:

 r_{II} = peak response from the Sample solution

 $r_{\rm S}$ = peak response from the Standard solution

- $C_{\rm S}$ = concentration of montelukast in the *Standard solution* (mg/mL)
- V = volume of *Medium*, 900 mL
- L = label claim (mg/Chewable Tablet)

Tolerances: NLT 80% (Q) of the labeled amount of montelukast $(C_{35}H_{36}CINO_3S)$ is dissolved.

Test 2: If the product complies with this test, the labeling indicates that it meets USP Dissolution Test 2.

Medium: 0.5% (w/v) Sodium dodecyl sulfate in water; 900 mL

Apparatus 2: 50 rpm

Time: 45 min

Solution A: 0.07 g/L of monobasic sodium phosphate

Solution B: Acetonitrile

Mobile phase: *Solution A* and *Solution B* (45:55). Add 1.33 mL/L of <u>triethylamine</u> and adjust with <u>phosphoric acid</u> to a pH of 6.7.

Standard stock solution: 0.1 mg/mL of montelukast from montelukast sodium hydrate prepared as follows. Transfer a suitable amount of montelukast sodium hydrate to an appropriate volumetric flask. Dissolve in 4% of the flask volume of <u>methanol</u> and dilute with *Medium* to volume. Determine the water content of montelukast sodium hydrate at the time of use.

Standard solution: 0.005 mg/mL of montelukast in *Medium* from the *Standard stock solution* **Sample solution:** Centrifuge a portion of the solution under test.

Chromatographic system

(See <u>Chromatography (621), System Suitability</u>.)

Mode: LC

Detector: UV 225 nm

Column: 4.6-mm × 5-cm; 1.8-µm packing L1

Column temperature: 35°

Flow rate: 1 mL/min

Injection volume: 100 µL

Run time: 1.5 times the retention time of montelukast

System suitability

Sample: Standard solution

Suitability requirements

Relative standard deviation: NMT 2.0%

Analysis

Samples: Standard solution and Sample solution

Calculate the percentage of the labeled amount of montelukast ($C_{35}H_{36}CINO_3S$) dissolved:

Result =
$$(r_{II}/r_{S}) \times C_{S} \times V \times (1/L) \times 100$$

 r_{ij} = peak response from the Sample solution

 $r_{\rm S}$ = peak response from the *Standard solution*

 $C_{\rm S}$ = concentration of montelukast in the *Standard solution* (mg/mL)

V = volume of *Medium*, 900 mL

L = label claim (mg/Chewable Tablet)

Tolerances: NLT 70% (Q) of the labeled amount of montelukast ($C_{35}H_{36}CINO_3S$) is dissolved.

• Uniformity of Dosage Units (905)

Procedure for content uniformity

Solution A, Solution B, Mobile phase, and **System suitability:** Proceed as directed in *Dissolution Test* 1.

Diluent: <u>Methanol</u> and <u>water</u> (3:1)

Standard solution (for 4-mg Chewable Tablets): 0.026 mg/mL of <u>USP Montelukast Dicyclohexylamine</u> <u>RS</u> in *Diluent*

Standard solution (for 5-mg Chewable Tablets): 0.033 mg/mL of <u>USP Montelukast Dicyclohexylamine</u> <u>RS</u> in *Diluent* Sample solution: Nominally (L/200) mg/mL of montelukast, where L is the label claim of montelukast in mg/Chewable Tablet prepared as follows. Transfer 1 Chewable Tablet to a suitable volumetric flask, add 25% of the flask volume of water, and let stand for 5–10 min until the Chewable Tablet has disintegrated. Add 55% of the flask volume of methanol, shake well, and sonicate for 70 min with occasional shaking. Cool to room temperature, dilute with methanol to volume, and mix well. Pass a portion of the resulting solution through a suitable filter or centrifuge to obtain a clear solution.

Chromatographic system: Proceed as directed in Dissolution Test 1, except use an Injection volume of 10 µL.

Analysis

Samples: Standard solution and Sample solution

Calculate the percentage of the labeled amount of montelukast (C₃₅H₃₆CINO₃S) in the Chewable Tablet taken:

= molecular weight of montelukast, 586.18 M_{r1}

= molecular weight of montelukast dicyclohexylamine, 767.50 M_{r2}

Acceptance criteria: Meet the requirements

Diluent, Solution A, Solution B, Mobile phase, Standard solution, System suitability solution, Sensitivity solution, Sample solution, Chromatographic system, and System suitability: Proceed as directed in the Assay.

Analysis

Samples: Standard solution and Sample solution

Calculate the percentage of any individual degradation product in the portion of Chewable Tablets taken:

$$(r_{IJ}/r_{S}) \times (C_{S}/C_{IJ}) \times (M_{r1}/M_{r2}) \times (1/F) \times 100$$

= peak response of any individual degradation product from the Sample solution r_{II}

= peak response of montelukast from the Standard solution r_s

= concentration of <u>USP Montelukast Dicyclohexylamine RS</u> in the *Standard solution* (mg/mL) C_{ς}

= nominal concentration of montelukast in the Sample solution (mg/mL) C_{II}

 M_{r1} = molecular weight of montelukast, 586.18

= molecular weight of montelukast dicyclohexylamine, 767.50 M_{r2}

F = relative response factor (see <u>Table 2</u>)

Acceptance criteria: See <u>Table 2</u>. Disregard any peak with an area less than that of the Sensitivity solution.
